Mr. McRae is currently working part-time for Lane ESD as the Reopening Advisor. His schedule would allow him to start as soon as this week with a tentative end date of October 1st. The cost of his services would be .5 FTE pay of the current Superintendent.

Mr. Oldham reported that Devery Stoneberg and Whitney Connolly expressed that they would be willing to fill in for the position as well.

The Board had a discussion and decided that a special board meeting should be held to allow all those being considered a chance to speak.
