#### **A Letter from Your District Superintendent**

I wanted to give you an update as to where we are as a school district as we are working through the COVID-19 crisis.

When Pleasant Hill School District started this journey back in March, there were many scientific knowns regarding students and scientific unknowns of COVID-19. Prior to COVID-19, the educational community fully knew the scientific research associated with students who do not spend time in-person for their education: academic loss, high failure rates, increasing achievement gaps, lack of student engagement. All are elements that we know are negatively affected by online learning, specifically for younger grades. Further, we knew the majority of child abuse cases are reported during in-person school. We knew that the social and mental well-being of students is dependent upon in-person interaction with peers. We also knew that, in many cases, in-person school is the safest place for many underserved and at-risk students.

This past March and throughout the summer, the scientific unknowns were centered around the effects of COVID-19 on students and teachers and the spread of the virus in schools. School districts, in coordination with the guidance of Ready Schools, Safe Learners (RSSL) provided by the Oregon Department of Education (ODE), developed school blueprints for safety measures and protocols for in-person instruction. However, the metrics embedded within the RSSL guidance, and imposed by the Oregon Health Authority (OHA) were clearly some of the most stringent nationwide, exceeding criteria listed by the Center for Disease Control (CDC), as well as neighboring states. Now, after nearly half the school year has been completed, the growing body of state, national, and international scientific research is clearly indicating that COVID-19 does not spread in schools with strict adherence to safety protocols as outlined in RSSL. We now have the data that supports students, and specifically elementary students, needing to be in-person for school. Each day that goes by without in-person instruction, Oregon students fall further and further behind peers in other states.

The governors' announcement on December 23, 2020, in conjunction with ODE, stating that Oregon's K-12 COVID-19 metrics are changing to "advisory" rather than "mandatory" surprised school districts throughout the state. In response, educational partners such as Oregon School Board Association (OSBA), Coalition of Oregon School Administrators (COSA), Oregon Education Association (OEA) and Oregon School Employees Association (OSEA) have been engaged in conversations with the Governor's office and with the Legislature about the need to return to in-person learning as quickly and safely as possible.

I want to emphasize that the Governor's decision about moving to advisory metrics does not change the requirement for schools and districts to follow RSSL safety protocols and guidance. This is particularly important, not only for the health and safety of students, staff, and families, but also to receive COVID-19 liability protection passed by the legislature in late December.

PHSD received guidance from ODE and OHA during the week of January 18 regarding updated metrics and information about how to process decisions locally in the context of allowing for the potential of more on-site education for our students. I want to assure you that PHSD will continue to advocate for a safe move to expand our in-person instruction during this pandemic as an option in the near future. We will also continue our distance learning option for those families who feel it is their best learning option for their children's needs.

#### A Letter from Your School Board Chair

Hello, Pleasant Hill families. Happy New Year!

As we journey into 2021, I think it is safe to say that we all hope this new year will be better than the last. 2020 brought us a global pandemic, record level unemployment and economic hardship, devastating wildfires, social unrest, and a contentious national election. 2020 also introduced "distance learning" into our educational system, turning many of our dining rooms and living rooms into makeshift classrooms. While distance learning is not ideal for most of our students, I am proud to say that the Pleasant Hill School District has made the most of this opportunity to show this community that we care about every one of our students. All staff have shown that they are willing to go the extra mile to serve students and their families the best we can, regardless of the challenges we face. The School Board greatly appreciates the hard work of Superintendent Linenberger and the entire staff as they continue to navigate constantly changing regulations and recommendations from our State and local officials to keep all of us safe while providing the best educational possible.

As we look towards the rest of this school year and beyond, PHSD remains focused on how we can continue to maximize our educational opportunities while keeping our students and staff safe. We have recently started providing Limited In-Person Instruction (LIPI) for students in grades 4-12 that is currently allowed under Oregon Department of Education (ODE) guidelines. This program allows small groups of students to receive on-site instruction for short periods of time while following detailed COVID-19 protocols. The District has also started upgrading air filtration systems in our buildings to remove airborne pathogens and improve indoor air quality. We recognize that maintaining clean air in our schools is a worthwhile investment not only now during the pandemic, but it will continue to provide benefits during future fire and flu seasons for years to come. Finally, we are starting to discuss how PHSD could maintain the ability for some students to continue to utilize distance learning even after COVID is behind us. While we recognize that most students are anxious to return to campus full time, we now know that some students have benefited from an online learning environment. We will continue to explore all options to make sure we are serving each student to the best of our abilities.

In closing, I just want to say that I am proud to be a member of the Pleasant Hill community, an Oregonian and a citizen of these United States of America. The primary purpose of the Budget Committee is to bring public participation into the budget development process. Their responsibilities are governed by Local Budget Law, in Oregon Revised Statutes (ORS) Chapter 294.

## PLEASANT HILL ELEMENTARY SCHOOL

### A Letter from the Principal

The students of Pleasant Hill Elementary have been busy on their journey to master the grade level standards. This school year is like none other. Our students are either participating in K-3 Exemption (a blend of in-person and distance learning), distance learning only, or 4th and 5th grade Limited-In-Person Instruction (LIPI) in addition to distance learning. Not only have the students been busy, but the level of parental/guardian support has been incredible.

We started the year with the staff reaching out to each family in their class, introducing themselves, and providing families an opportunity to learn more about the year to come. This was followed by "Beep and Greet the Teacher" prior to the start of school. As part of the "Beep and Greet," Chromebooks were distributed to families for students to use as part of their daily school experience this year. Students and their parents/guardians log on to Zoom, Seesaw, Dreambox, and Lexia Core 5, to name a few of the programs used daily.

The first day of school arrived and we had to pivot, canceling the start of school due to the wildfires, ultimately delaying our first day by a week. When the first day finally arrived, both staff and students were excited to be back in session either K-3 on-site or K-5 on Zoom. Families quickly adjusted to all the changes in practices, such as not being able to walk students to class, sending their students with a mask, water bottle, and their Chromebook daily, or assisting students attending Zoom classes and completing their daily assignments at home.

"Monthly Materials Distribution Days" were introduced in September. Families whose students are participating in distance learning only are able to come to the school and pick up materials to support their student's education such as whiteboards, novels, textbooks, etc.

Our PTO graciously volunteered to support students this year in the area of literacy. Each month books are purchased and distributed to encourage reading. In addition, the PTO Board creates monthly incentive activities for students to complete after reading their new book, like send your teacher a video clip sharing your favorite part of the story via Seesaw.

In October, we held Zoom goal/parent conferences. Teachers invited parents/guardians to Zoom meetings, set-up phone conferences, or participate in socially distanced outdoor conferences. Just like in years past, the purpose was to set goals for their students for the year. The feedback we received was very positive. Parents are appreciative of having an opportunity to meet with teachers, building relationships and forming partnerships to assist our students in being successful this year.

During November, we welcomed 72 students in 4th and 5th grade back to campus. These families accepted an invitation to participate in LIPI as well as distance learning. K-3 students continue to either participate in a blend of on-site and distance learning, or continue distance learning only. Our school community also collectively worked together and pulled off a successful community food drive during November.

December has been a month of our students giving back to the community. This year, due to COVID-19, we were not able to hold our annual Winter/Holiday music program. Instead, Mr. Strong, our elementary music teacher, held the first PHES Holiday Sing-along via Zoom. It was an evening filled with song and dance.

Here we are in January, getting ready to prepare report cards for the 2nd quarter of the school year. It is a great time to reflect on the academic growth of our students as they continue to make their journey towards mastering their current grade levels' standards. To assist with this growth, students will continue logging in daily to Lexia Core 5 Reading, Dreambox Math, as well as attending classes receiving daily instruction either on-site or Zooming on-line.

Oh, the places we have yet to go!

## **How to Protect Your Family from COVID-19**

After months of dealing with the ongoing pandemic, it may seem that everything that could possibly be said about COVID-19/the coronavirus has already been said. You likely have your own family routine down after months of dealing with suggestions and restrictions due to the pandemic. According to the CDC, there are some simple and practical steps that families can do to keep themselves and their students safe and healthy:

#### Teach and reinforce everyday preventive actions

- Wash hands with soap and water for 20 seconds or use hand sanitizers if soap and water are unavailble
- Wear a mask if you're two years old or older
- Avoid close contact with people who aren't part of your household (at least six feet of distance)
- Avoid people who are sick and coughing or sneezing
- Cover your own coughs and sneezes

#### Keep up-to-date with other healthcare matters

- Schedule and attend routine well-child and vaccine visits
- Prepare for visits by asking your healthcare provider how healthy patients are being kept separate from those who may be sick
- If you or your child have any COVID-19 symptoms, notify your healthcare provider before your office visit

# RECOMMENDATIONS FOR NON-ESSENTIAL TRAVEL

Travel to/from other states or countries could increase the risk of COVID-19 spread. Avoiding travel, particularly travel through shared conveyance such as air, bus, or rail travel, can reduce the risk of virus transmission and bringing the virus back to Oregon. All non-essential travelers, including returning Oregon residents, should but are not required to:


- Practice self-quarantine for 14 days after arrival
- Limit their interactions to their immediate household

Those who have traveled to or from their home may consider ending quarantine early if they have not had any symptoms:

- After 10 days, without any testing;
   OR
- After 7 days, if they have had a negative result by an antigen or polymerase chain reaction (PCR) test within the 48 hours before ending quarantine.

Residents of Oregon should but are not required to stay home or in their region and avoid non-essential travel to other states or countries.

These recommendations do not apply to individuals who cross state or country borders for **essential travel**.



#### **TECHNOLOGY: VERIZON HOTSPOT**

Please return the Hotspot at your earliest convenience to the Pleasant Hill High School Front Office if this is the case. PHSD continues to pay for the device with monthly charges, and there are others who could use the device if it is not currently being used.
